RESOLUTION NO. 63

APPROVING ORDINANCE NO. 4, SERIES OF 2013

WHEREAS, consistent with the provisions of local autonomy and decentralization under the Local Government Code, the provisions for the delivery of basic services are devolved from the national government to Local Government Units;

DEFICE OF THE VICE GOV.

WHEREAS, one of the devolved functions of Local Government Unit is the provisions of health and social services, and one of the district hospitals in the province which is the Dinalupihan District Hospital was approved by virtue of R.A. No. 7535 on May 22, 1992, increasing its bed capacity from twenty-five (25) to fifty (50) prior to its devolution to the Provincial Government of Bataan;

WHEREAS, the Dinalupihan District Hospital was renamed to Jose C. Payumo, Jr. Memorial Hospital by virtue of R.A. No. 7414 and is now devolved to the Provincial Government of Bataan;

WHEREAS, the bed capacity of the mentioned hospital is proposed to be increased from fifty (50) to seventy-five (75) in line with the proposed TWENTY MILLION (PHP20 M) PESOS expansion of buildings to be constructed by the Department of Health (DOH);

WHEREAS, to further support this noble project which would redound to the benefits of the local constituent of Dinalupihan and its immediate Local Government Units;

On motion of Board Member Jovy Z. Banzon, which was unanimously seconded;

BE IT ORDAINED, by the Sangguniang Panlalawigan of Bataan to enact the following Ordinance:

ORDINANCE NO. 4

AN ORDINANCE INCREASING THE BED CAPACITY OF JOSE C. PAYUMO, JR. MEMORIAL HOSPITAL FROM FIFTY (50) TO SEVENTY-FIVE (75) BEDS AND APPROPRIATING FUNDS THEREFOR.

Section I. This Ordinance hereby increases the bed capacity of the Jose C. Payumo, Jr. Memorial Hospital from fifty (50) to seventy-five (75) beds and appropriating funds for the purpose;

Section II. The increase in the bed capacity of the mentioned hospital as stated in Section I thereof is in line with the proposed TWENTY MILLION (PHP20 M) PESOS expansion of buildings to be constructed by the Department of Health (DOH);

Section III. This ordinance shall take effect upon approval.

ENACTED: AUGUST 7, 2013.

RESOLVED FINALLY, that copies of this resolution be furnished the Provincial Governor, Hon. Albert S. Garcia, Hon. Maria Angela S. Garcia, Municipal Mayor of Dinalupihan, and other offices concerned for information and appropriate action.
