ORDINANCE NO. 5

AN ORDINANCE APPROVING THE INTERNAL RULES OF PROCEDURE OF THE SANGGUNIANG PANLALAWIGAN OF BATAAN AS AMENDED.

Section I. This Ordinance hereby adopts and approved the Internal Rules of Procedure of the Sangguniang Panlalawigan of Bataan as amended;
