ORDINANCE NO. 04 Series of 2018

AN ORDINANCE CREATING THE POSITION OF PROVINCIAL GOVERNMENT DEPARTMENT HEAD (SG-26) IN THE OFFICE OF THE PROVINCIAL GOVERNOR, PROVINCE OF BATAAN.

WHEREAS, submitted for review and consideration of this Body was a request from the Provincial Governor, Hon. Albert S. Garcia, for the passage of an ordinance creating the position of Provincial Government Department Head (SG-26) in the Office of the Provincial Governor, Province of Bataan;

WHEREAS, the Local Government Code of 1991 or RA 7160 empowers Local Chief Executives to appoint officials and employees whose salaries are wholly or mainly paid out of provincial funds and whose appointment are not otherwise provided in the Code, as those he maybe authorized by law to appoint (Article 85(b)(1)(viii));

WHEREAS, the proposed position will be instrumental in aiding and assisting the Provincial Governor in managing and overseeing the personnel in the Provincial Governor's Office, handling confidential tasks as maybe given by the Governor, with the end in view of bringing an orderly and efficient PGO staff support;

WHEREAS, the proposed position of Provincial Government Department Head shall have a Salary Grade-26 and is primarily confidential and co-terminus and accordingly be exempted from the qualifications standard prescribed in Part 1, Item 6 of the Civil Service Commission MC No. 12, series of 2003 (Revised Policies on Qualifications Standards);

WHEREAS, upon review and deliberation, this Body finds the request in order without prejudice to existing Civil Service rules and regulations;

NOW THEREFORE, be it enacted by the Sanggunaing Panlalawigan, in a session duly assembled that:

SECTION 1. CREATION. The following co-terminus position is hereby created under the Office of the Provincial Governor:

Dept.	Position	Salary Grade/Step	Remarks
PGO	Provincial Government Department Head	SG-26	Co-Terminus

SECTION 2. DUTIES AND RESPONSIBILITIES. The duties and responsibilities of the appointee is primarily confidential and co-terminus, including but not limited to aiding and assisting the Governor in managing the PGO personnel, oversee its operations and handle confidential tasks given by the Governor with the end in view of bringing an orderly and efficient PGO staff support.

SECTION 3. FUNDING. The corresponding salaries and other benefits of the new position shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 4. SEPARABILITY CLAUSE. If any part of this ordinance is declared not valid, unconstitutional or unlawful, such declaration shall not affect or impair the remaining provisions, sections or parts hereof, which shall remain and continue to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect after ten (10) days from the date, copy thereof is posted in a bulletin board at the entrance of the Provincial Capitol Building and at least in two (2) other conspicuous places,
