APPROVING TO SCRAP AND BUILD POSITIONS AT THE ORANI DISTRICT HOSPITAL.

"WHEREAS, the Sangguniang Panlalawigan is in receipt of a request from the Provincial Governor, Hon. Albert S. Garcia, to scrap and build positions in Orani District Hospital, Orani, Bataan;

WHEREAS, Article 98 (1)(viii) of the IRR of RA 7160 or the Local Government Code of 1991 provides that the Sangguniang Panlalawigan, as the legislative body of the province, shall determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from provincial funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the Provincial Government;

WHEREAS, upon review and deliberation, the Sangguniang Panlalawigan finds the same in order without prejudice to relevant laws, rules and regulations;

NOW THEREFORE, be it enacted by the Sangguniang Panlalawigan, in a session duly assembled that:

SECTION 1. SCRAP AND BUILD POSITION. The following position(s) is hereby scrapped and created:

Orani District Hospital:

SECTION 2. RATIONALE. The Orani District Hospital is mandated to promote and improve healthcare of the people by providing available and accessible preventive and curative health services. It is a 45-bed Level 1 government hospital administered and operated by the Provincial Government of Bataan. With the increasing number of health workers needed in hospitals, the positions herein created are essential considering the 2013 DBM Guidelines on the recommended staffing pattern and of government hospitals and the need to strengthen the resolve in COVID-19 response.

SECTION 3. FUNDING. The corresponding salaries and other benefits of the new positions shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 4. SEPARABILITY CLAUSE. If any part of this Ordinance is declared not valid, unconstitutional or unlawful, such declaration, remaining provisions, sections or parts hereof shall remain and continue to be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE. This Ordinance shall take effect after ten (10) days from the date, copy hereof is posted in a bulletin board at the entrance of the Provincial Capitol Building and in at least two (2) other conspicuous places.
