SECTION 2. RATIONALE: There is a need to establish Agricultural Biosystems Engineering (ABE) unit to support the implementation of the Garcia-Mandanas Ruling, and will serve as counterpart of the Regional Field Offices for small-scale irrigation, farm to market roads, post-harvest facilities and other agricultural infrastructure projects.

SECTION 3. FUNDING. The corresponding salaries and other benefits of the new positions shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.


