ORDINANCE NO. 22 Series of 2021

APPROVING THE CREATION OF A CO-TERMINUS POSITION IN THE PROVINCIAL GOVERNOR'S OFFICE - PROVINCE OF BATAAN.

Sponsored by: HON. NOEL JOSEPH L. VALDECAÑAS

WHEREAS, the Sangguniang Panlalawigan is in receipt of a request from the Provincial Governor, Hon. Albert S. Garcia, for the creation of a co-terminus position in the Provincial Governor's Office - Province of Bataan;

WHEREAS, attached to said request is the Certificate of Availability of Fund Sources issued by the Local Finance Committee and other documents supporting the said request which form as integral part of this Ordinance;

WHEREAS, Art. 98 (1)(viii) of the IRR of RA 7160 or the Local Government Code of 1991 provides that the Sangguniang Panlalawigan as the

legislative body of the province shall..... determine the positions and salaries,

wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from provincial funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the Provincial Government;

WHEREAS, the Provincial Governor's Office (PGO) is mandated to exercise powers and perform the duties necessary to promote the general welfare of the province, to include the programs, policies and projects;

WHEREAS, to implement and undertake these tasks and functions, the creation of a co-terminus position where duties and responsibilities imply not only confidence in the aptitude of appointees but primarily close intimacy, requires the highest degree of trust and confidence and in close proximity with the Provincial Governor, thus the creation of the co-terminus position of ONE (1) Driver II, SG-4 is requested;

WHEREAS, upon review and deliberation, the Sangguniang Panlalawigan finds the same in order without prejudice to relevant laws, rules and regulations;

NOW THEREFORE, be it enacted by the Sangguniang Panlalawigan, in a session duly assembled that:

SECTION 1. CREATION:

a. ONE (1) Co-terminus position, Driver II, SG-4

SECTION 2. FUNDING. The corresponding salaries and other benefits of the new position shall be appropriated and incorporated in the Annual or Supplemental Budget of the Provincial Government of Bataan.

SECTION 3. SEPARABILITY CLAUSE. If any part of this Ordinance is declared not valid, unconstitutional or unlawful, such declaration shall not affect or impair the remaining provisions, sections or parts hereof, which shall remain and continue to be in full force and effect.

SECTION 4. EFFECTIVITY CLAUSE. This Ordinance shall take effect after ten (10) days from the date copy hereof is posted in a bulletin board at the entrance of the Provincial Capitol Building and in at least two (2) other conspicuous places.
