Provincial Population Office of Bataan

The Provincial Population Office of Bataan (PPO) is mandated to serve as the overall coordinating, policy-making, planning, and monitoring body of all population-related programs by:

- A. Empowering couples and individuals to achieve their desired number, timing and spacing of children in the context of informed choice and responsible parenthood;
- B. Enable adolescents to realize their full potential and total well-being; and
- C. Mainstream population factors in sustainable development initiatives.

In doing so, the office has key organizational strategies that are anchored in the Philippine Population Development Program (PPDP) namely: 1) Adolescent, Health and Youth Development Program (AHYD); 2) Responsible Parenthood and Family Planning (RPFP); and 3) Population and Development Integration Program (POPDEV). In addition, PPO also leads the Technical Working Group of the Gender and Development Focal Point System of the province making Integration of Gender and Development Dimension as its additional key organizational strategy.

Overall, PPO bagged prestigious awards in 2022 which cemented the office's outstanding efforts, initiatives and performances on population and development not only in the province but in the region and country as well.

RESPONSIBLE PARENTHOOD AND FAMILY PLANNING (RPFP)

The Responsible Parenthood and Family Planning (RP-FP) Component of the PPDP is viewed as a significant strategy to the provision of quality health services recognizing the strong inter-relationship between closely spaced and frequent births and maternal and child health and survival. A large proportion of maternal and child morbidity and mortality can be prevented through more responsible reproductive health and sexual behavior. The said component also takes explicit consideration of the gender issues affecting the reproductive health of couples and individuals, and addresses these issues through the conduct of different programs, projects, and activities under the RP-FP.

RPFP priority strategies are geared towards assisting couples to achieve their desired number and spacing of children within the demand of responsible parenthood through effective family planning. It specifically aims to attain zero unmet need for family planning through increased access to FP Information and services.

1. Pre- Marriage Orientation and Counseling (PMOC)

PD 965 issued on July 20, 1978 mandates all applicants for marriage licenses to undergo Pre-Marriage Counseling.

The PMOCs for all would-be couples are continuously being implemented at the 11 Municipalities and 1 City of the province with PPO Bataan's personnel serving as the front-liners at the LGU Level. In order to ensure the systematic and efficient delivery service, PPO-Bataan successfully facilitated the approval of Executive Order No. 174, S.2022 "An Order Creating the Pre-Marriage Orientation and Counseling (PMOC) Technical Working Group in the Province of Bataan and Recognizing the Bataan League of Pre-Marriage Counselors".

To further strengthen the PMOC of Bataan Province, the PPO also facilitated the following:

June 22, 2022- Semi Annual Assembly for LGU's PMOC Team

November 7-9, 2022- Simultaneous PMOC Refresher Course for all the PMOC Teams of Bataan



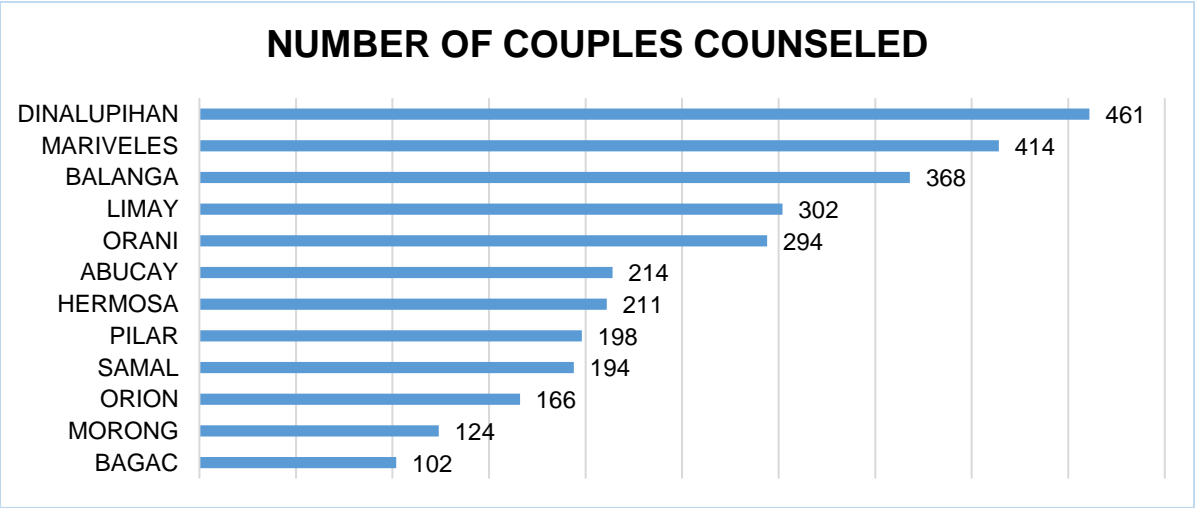

Overall, a total of 3,048 would-be couples were provided orientation on pre-marriage in the Province of Bataan. This is 14% higher than last year’s 2,616 would-be couples. Overall, the series of PMOC conducted resulted in an average of 99.88% of would-be couples with 3 or less than the desired number of future children.

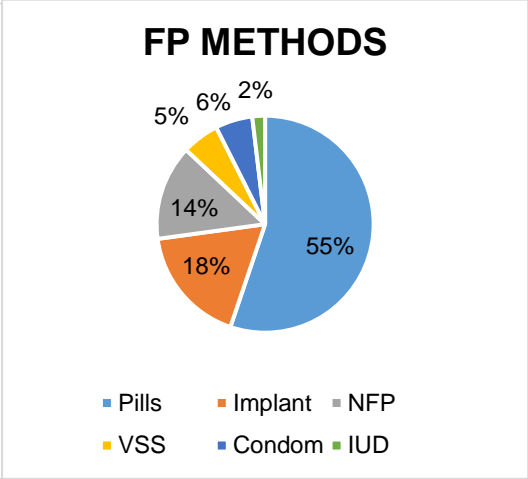
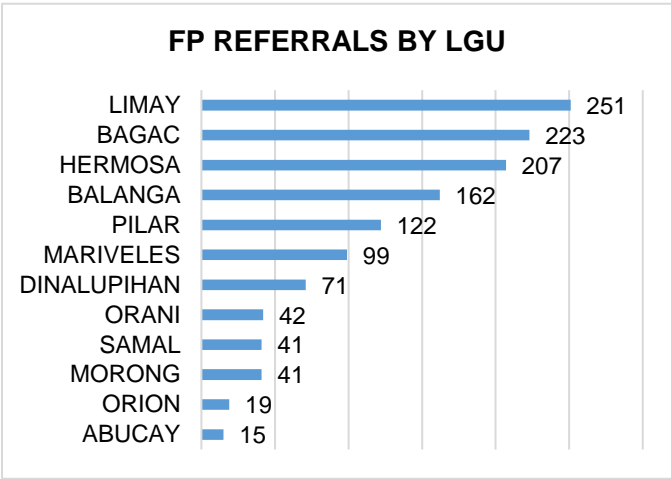
