COMMITTEE REPORT

COMMITTEE ON AGRICULTURE, FOOD AND FISHERIES

Our committee received a referral concerning the following matter:

Agenda No. 250 - Ordinance No. 17, series of 2022 passed by the Sangguniang Bayan of Pilar, Bataan, entitled "AN ORDINANCE INSTITUTING AND IMPLEMENTING THE REGISTRATION OF OWNERSHIP OF AGRICULTURE AND FISHERIES MACHINERY AND EQUIPMENT IN ACCORDANCE WITH THE JOINT MEMORANDUM CIRCULAR NO. 2018-02 BY THE DEPARTMENT OF AGRICULTURE AND THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT RELATIVE TO THE NATIONAL GUIDELINES FOR THE REGISTRATION OF OWNERSHIP OF AGRICULTURAL AND FISHERIES MACHINERY AND EQUIPMENT WITHIN THE TERRITORIAL JURISDICTION OF PILAR, BATAAN."

Section 19 of RA 10601 otherwise known as the "Agricultural and Fisheries Mechanization (AFMech) Law" mandates all owners of agricultural and fishery machinery and equipment must register these with the agriculture offices of municipal and city government units.

The purpose of the registration of agricultural and fisheries machinery and equipment in the Municipality of Pilar is to establish ownership and create a national database of machinery and equipment for planning and monitoring purposes and to ensure the quality and safety of agri-fisheries machineries and equipment as well as rational planning and programming of government investments and resources.

The committee after its deliberation held last July 6, 2022 hereby recommends to declare the validity of Agenda No. 250 after rules are suspended.
