

Establishment and Maintenance of Provincial Plant Nursery

One of the goals of the Provincial Nursery is to be a self-sustaining nursery, where our office will propagate and also provide seedlings for the province of Bataan.

For 2022, the Forest Management Section propagated 19,000 Narra (*Pterocarpus indicus*) and 1,500 Falcata (*Falcataria falcata*) totaling 20,500 seedings.







Granting of seedlings, seeds, and/or farm inputs

Within the same year, the office was able to distributed 49,560 various seedlings, seeds, and other equipment and tools for farming, such as a wheelbarrow and watering can. Request letters, Requisition and Issue Slip (RIS), and monthly inventory reports are provided for documentation and record-keeping.

Tree Planting Activities



2. Transition activities for the upgrading of Pawikan Conservation Center (PCC). One of the options that the Provincial Government will explore in the future to revamp pawikan conservation efforts in Bataan is the reformation of the existing management structure of the Center. The upgrading will provide access to better pawikan conservation and learning facilities as well as boost the eco-tourism in the Province of Bataan. Transition activities will be carried out the PCC gets turned over to the PGB. These transition activities included the coordination with the Bantay Pawikan, Inc. and appraisal core team for the conduct of an appraisal of the existing structures and equipment at the PCC. The Provincial Engineer's Office conducted a survey in the PCC and submitted an appraisal report dated 14 December 2022 to our office.





(3) Development of protocol for beach resorts during nesting and hatching season. This milestone aimed for the passage of a Provincial Ordinance that will prescribe protocols and guidelines to various sectors located pawikan nesting sites, such as the implementation of curfew hours during nesting and hatching season, and proper handling and releasing of pawikan hatchlings. The project team conducted initial meetings with stakeholders in Morong, Bagac, Limay and Mariveles to present the initial concept of the protocol. Last October 24, 2022, Provincial Ordinance No. 24, Series of 2022 titled "An Ordinance Prescribing Rules and Regulations Governing Marine Turtle (Pawikan) Interaction during Nesting and Hatching Season and the Management of Threats on Nesting Habitats in the Province of Bataan and Providing Penalties for Violation Thereof" was passed and immediately cascaded to the stakeholders, just in time for the pawikan nesting season.

PROVINCIAL ORDINANCE NO. 24 Series of 2022

AN ORDINANCE PRESCRIBING THE RULES AND REGULATIONS GOVERNING MARINE TURTLE (PAWIKAN) INTERACTION DURING NESTING AND HATCHING SEASON AND THE MANAGEMENT OF THREATS ON NESTING HABITATS IN THE PROVINCE OF BATAAN AND PROVIDING PENALTIES FOR VIOLATION THEREOF.

WHEREAS, Article II, Section 16 of the 1987 Constitution provides that "The State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature";

WHEREAS, Republic Act 9147, known as "Wildlife Conservation and Protection Act of 2001" aims, among others, to conserve and protect wildlife species and their habitats to promote ecological balance and enhance biological diversity;



(4) Training on proper pawikan handling. The three-day training titled "Capacity Building Workshop for Marine Turtle Conservation in Bataan Province" was held at Brizo Resort, Morong, Bataan last August 24-26, 2022. The training participants included members of People's Organizations for pawikan conservation, representatives from the Morong Beach Resorts and Tourism Stakeholders Association (MBRTSA), implementing partners from the private sector, National Government Agencies (NGAs), select PGB Offices and the research division of the BPSU.







(5) Pawikan public information campaign. To raise proper knowledge and awareness among locals and tourists, information, education, and communication (IEC) campaign was part of the project. This includes social media posts, radio guesting, the conduct of the Environmental Forum, and the production of IEC materials. The 1PawiCAN official Facebook Page was created last September 2, 2022 to disseminate information about pawikan and the activities of the Network. On October 6, 2022, Ms. Karen June A. Balbuena, a technical staff of the PG-ENRO, guested on the Central Luzon State University (CLSU) Radio Station to disseminate information about marine turtle conservation. The Environmental Forum, an activity in collaboration with the Provincial Tourism Office, was conducted in select elementary schools in celebration of the Pawikan Festival in the Province.












(6) Additional Milestone: Conduct of Night Patrol. A total of two night patrols were conducted by the PG-ENRO. The first night patrol was held at the PCC in Nagbalayong, Morong, Bataan on November 25, 2022. Participants included Brgy. Luz and Brgy. Lamao Pawikan Conservation and Protection Groups. The second one was held at the Pag-Asa Pawikan Protection and Conservation Center, Bagac, Bataan, and participated by the ICHTHUS Society of BPSU-Orani Campus. Night Patrol is one of the activities of the 1PawiCAN that intends to expand the knowledge of the stakeholders on the importance of marine turtles and intensify marine turtle conservation in the Province of Bataan.

International Coastal Clean-up

The International Coastal Clean-up (ICC) is an initiative of the Center for Marine Con-(CMC). servation a non-profit. nongovernment organization (NGO) based in Washington D.C., USA. It is observed every third Saturday of September in over 100 countries including the Philippines and in 36 U.S. states. In the Philippines, the activity started in 1994 and is being organized by the International Marine Alliance-Philippines (IMA). IMA is a non-profit NGO whose missions are to conserve marine biodiversity, protect marine environments, and promote sustainable use of marine resources for the benefit of local people.

Since 1999, Bataan province responded to the call for international coastal cleanup. This is very timely considering that the province is moving towards being a new frontier of socio-economic development. Furthermore, the province has an extensive coast-line subjected to various refuse, especially on the Manila Bayside. The Bay itself is considered a pollution hotspot in the East Asian Seas region.

Organizational Meetings through Zoom




Results


Fourteen thousand two hundred fifty-one (14,251) volunteers participated in the conduct of coastal clean-up activity for the whole province and collected a total of six thousand fifteen (6,715.4) sacks of trash weighing a total of seventy-nine thousand eight hundred twenty-two (79,822) kilograms. The total estimated distance cleaned was two hundred seventy-six point fifty-four (276.54) kilometers. Volunteers cleaned the different types of environments including inland, coastal, and freshwater.




The total number of volunteers who participated in the coastal clean-up activity per municipality/City.

Mangrove Rehabilitation and Ecotourism Project

In 2022, the PG ENRO-ICM Section together with the GNPower Mariveles Energy Center Ltd. Co. (GMEC) conceptualized a project on the "Improvement of Orani Coastal and Marine Biodiversity (Mangrove Nursery Establishment, Mangrove Reforestation and Improvement of Carbon Sequestration at Tubo Tubo Island, Orani, Bataan). A series of meetings was conducted together with the People's Organization at Tubo Tubo Island and the LGU Orani. A project proposal was drafted by the ICM section of the PG-ENRO and presented to all the stakeholders.

Later on, a Memorandum of Agreement was drafted among the Provincial Government of Bataan, Municipality of Orani, DENR-PENRO, GMEC and the Tubo Tubo Fisherfolks for the implementation of the project.


However, during the final meeting, the DENR-PENRO decided to postpone the implementation of the project due to some technical problems at the project site.

In the Cash for Work Program implemented by the Provincial Social Welfare Development Office (PSWDO) together with the Provincial Disaster Risk Reduction and Management Office (PDRRMO) and the PG-ENRO, a total of P210,000 was allocated for the the propagules planted by the Climate Change Adaptation and Mitigation (CCAM) beneficiaries. Mangrove planting was done in Orani where a total of 42,000 Propagules and 3,000 seedlings were planted. The LGU Orani, its beneficiaries and some stakeholders actively took part in the implementation of the program.



To rehabilitate some of the mangrove sites, planting activities were done in the municipalities of Abucay, Pilar, Orion, and Limay in May. While funded and implemented by the PDRRMO, full assistance was provided by the PG-ENRO, LGUs, and other stakeholders like the Philippine National Police (PNP), PGB employees, other government offices and NGOs and the People's Organizations in each municipality.

For the repair of the Mangrove Eco-Tourism Site in Brgy. Camachile, Orion, Bataan, the Philippine Resins Industries Inc. funded and released a total amount of Php 288,000 last October to replace the bamboos with concrete as the latter is more than durable and likely to last for a long time. As of December 31, 2022, almost 50% of the construction was made and the rest is expected to be completed by 2023.

MINING ACT COMPLIANCE

In support to the implementation of the Philippine Mining Act of 1995, also known as R.A. 7942, and its implementing rules and regulations, the PG-ENRO ensures regular monitoring of the ongoing progress and environmental rules compliance of permitted land development projects in the province. Applications for certifications, special excavation permits for area development, and quarrying are processed and screened by its Mines and Geosciences Section.

The PG-ENRO aims to promote and encourage responsible development including but not limited to exploration and excavations as long as proper environmental protection measures are observed. For CY 2022, the office has monitored a total of twenty-nine (29) area development and three (3) river desilting projects. During the first semester, five (5) quarry areas were monitored whereas only four (4) were visited during the second semester.






Location map showing the approved permits and certifications for CY 2022

New permits and certifications were also issued after the assessment of each applications and requests, respectively. For 2022, 23 certifications allowing the simple developments within private lands in preparation for various future uses such as residential, industrial, or agricultural areas. Fifteen (15) special excavation permits for area developments were also issued. Through the assistance of the Provincial Mining Regulatory Board (PMRB) of Bataan, one quarry permit application located in the municipality of Mariveles was also approved.

Despite the aim of the PGB to encourage developments in the province, assessments of the proposed projects were also vital in the decision making for the approval of permits or any related documents. Unfortunately, two (2) special excavation permit applications were denied. The proponents may reapply however, recommendations and suggestions given to them should reflect on their improved program of works.


Validity of the issued certifications or permits, whichever may apply, varies depending on the scale of the project and its intended purpose. The map below shows the summary of the existing permits and certifications in the province. Some of the permit areas are tagged as inactive due to various reasons. Regardless of their status, regular monitoring are still being conducted with the active permit areas prioritized. Aside from the compliance with the environmental laws and regulations set by their respective permits, the office also assess any potential adverse impacts to the community. Operation within permitted areas with received complaints are put on hold temporarily until the issue has been resolved.






SMALL-SCALE QUARRYING PERMIT

Majority of the land developments in the Province of Bataan entail extraction of materials which comprise of either overburden, common barrow, unconsolidated loose materials, and/or boulders. Following the provisions set by People's Small Scale Mining Act of 1991, or the RA 7076, along with the Local Government Code, Philippine Revenue Code, and the Bataan Environment Code, the PGB is hereby authorized to charge associated fees from the extraction and commercialization of materials for the protection of the environment and adjacent communities.



Breakdown of collections per category

For calendar year 2022, a total of Php 3, 771, 643.00 was collected from the projects within Bataan. during the first semester alone, 3, 007, 501.00 was generated and a significant percentage of the aforementioned revenue originated from the annual fixed tax of the operational crushing and batching plants in the province. Second semester garnered 764, 142.00 from the extractions of boulders and common barrows within project areas.

PROVINCIAL MINING REGULATORY BOARD (PMRB)

With the activation and mobilization of the Bataan Through the three (3) conducted regular meetings, Provincial Mining Regulatory Board (PMRB) through an interim, the PGB through its ENRO is designated as the Secretariat. The Board works together with the PGB in the approval of mining related permits by functioning as the body responsible for the thorough evaluation and screening of project applications.

one quarry permit was endorsed by the Board to and approved by the Provincial Governor. Updating of the general status of the project areas are the usual agenda of the regular meetings and due to the change of administration last May to June, the second and third quarterly meetings were conjoined. Special meetings were dedicated to address issues and immediate concerns that affect the application progress of proponents and/or operation of the permittees.

ENVIRONMENT CODE REVISION

In pursuit of continuous improvement and better management of the resources of the Province of Bataan, the PGB through its EN-RO passed the Environment Code in 2019. As any law, revisions are deemed necessary after encountering various situations. To improve the monitoring and regulation of the permits and developments in the province, certain clauses of the Environment Code were subject for revision. The PG-ENRO partnered with the Provincial Legal Office and the Sangguniang Panlalawigan in improving the clauses covering the types of permits, their classifications, required documents, and fees. The revision generally aims to re-align the classification scheme to be used for the segregation of permits to be applied which is beneficial not only to the proponents but also to the monitoring body.

The proposed revision also included the formulation of a Provincial Anti-Illegal Quarrying and Excavation Task Force composed of several representatives from the provincial and local government units, as well as private institutions such as the trucker's association or any equivalent entity. Its establishment shall aid the PG ENRO in more effectively monitoring all permit areas in the province and regulate the utilization of the land and mineral resources of Bataan.

Should the proposed revisions be approved, changes in the classification of appropriate permit to be applied will transpire and it is projected to result in better program implementation and more effective monitoring along with more sustainable developments in the areas of interest.





MANAGEMENT





Solid Waste Management (SWM)

For the year 2022, status quo is maintained on waste collection and street sweeping within the Provincial Capitol Compound. As part of its assistance to the pandemic response, PG-ENRO also continues to facilitate the contracting of hauling of hazardous waste from the Provincial Health Office and District Hospitals. In recognition of its effort, PG-ENRO was awarded as the "Most Outstanding Province in implementation of Ecological Solid Waste Management by the DENR-EMB Region 3.







B.Y.O.B sa Bunker



PG-ENRO implemented policies that focus on waste prevention and reduction of solid waste which are higher on the hierarchy of SWM alternatives. On the PGB level, "Bring-Your-Own-Baunan" was implemented which gave incentives such as discounts for employees that will bring their own food containers to be used in Bunker's cafeterias and pantries. Specified unnecessary single-use plastics were also prohibited entry inside the Bunker.

Talisay River Task Force

Talisay River Task Force was established under Executive Order No. 66, Series of 2022, deputizing consolidated manpower from the Provincial Government of Bataan (PGB) and the local government units (LGUs) of Pilar and Balanga City to penalize violators caught littering along and near Talisay River.

EXECUTIVE ORDER NO. 66

Series of 2022

CREATING THE TALISAY RIVER PROVINCIAL TASK FORCE, DEFINING ITS COMPOSITION, POWERS, AND FUNCTIONS, AND FOR OTHER PURPOSES, TO EFFECTIVELY IMPLEMENT THE RELEVANT PROVISIONS OF THE BATAAN ENVIRONMENT CODE AND THE TALISAY RIVER REHABILITATION ORDINANCE OF THE CITY OF BALANGA AND MUNICIPALITY OF PILAR, BATAAN

WHEREAS, Article II, Sections 15 and 16 of the Constitution provide that the State shall protect and promote the right of the people as well as their right to a healthful and balanced ecology in accord with the rhythm and harmony of nature;

WHEREAS, pursuant to Republic Act No. 7160 (Local Government Code of 1991), Republic Act 9003 (Ecological Solid Waste Management Act of 2000), Republic Act No. 9275 (Philippine Clean Water Act), and Presidential Decree No. 1067 (Water Code of the Philippines), it is declared the policy of the State to ensure the protection of public health and environment;

WHEREAS, the continuing Supreme Court Mandamus on Manila Bay Clean-Up and Rehabilitation specifically identifies the Talisay River within the territorial jurisdiction of the City of Balanga and Municipality of Pilar, Province of Bataan as a major tributary to the Manila Bay;

WHEREAS, the Sangguniang Bayan of Pilar and Sangguniang Panlungsod of Balanga City jointly passed Ordinance No. 6-2008, otherwise known as the Talisay River Rehabilitation Ordinance, which shall include and encompass all acts and omissions in and along the Talisay River that is within the territorial jurisdiction of these two LGUs;

WHEREAS, Sections 4 and 5 of the Talisay River Rehabilitation Ordinance prohibits and penalizes the dumping of garbage and waste materials and other similar activities in the Talisay River;

WHEREAS, Sections 69 and 70 of Provincial Ordinance No. 03, series of 2019, otherwise known as the Bataan Environment Code, prohibits and penalizes the littering, throwing, and dumping of waste matters in public places, such as roads, sidewalks, canals, esteros or parks, and establishment, or causing or permitting the same, among other acts;

WHEREAS, pursuant to Section 2 of Executive Order No. 136, series of 2021, the Provincial Solid Waste Management Board (PSWMB) of the Province of Bataan shall provide necessary logistical support to its component city and municipalities, and allow for the clustering of LGUs for the solution of common solid waste management problems;

NOW THEREFORE I, ALBERT S. GARCIA, as the Chief Executive of the Province of Bataan, by virtue of the powers vested in me by law, do hereby create the Talisay River Provincial Task Force and define its composition, powers, and functions.

Section 1. Composition. The Talisay River Provincial Task Force shall be composed of the following:

Environmental Compliance Monitoring


In C.Y. 2022, the PG-ENRO continued its mandate and function of ensuring the implementation of relevant environmental laws and ordinances by monitoring the compliance of relevant stakeholders, as well as monitoring of ambient air and water quality in the province.


As part of the office's Provincial Environmental Monitoring Program, the water quality of the Talisay River and Orani River was regularly monitored. These are the two major rivers contributing to the water quality of Manila Bay. Monitoring results show that overall, the water quality of Talisay and Orani Rivers remains to be within Class C, or suitable for agricultural purposes, based on water quality standards prescribed by DENR Administrative Order No. 2016-08.

However, looking at individual parameters, one finding of the water quality monitoring is that the downstream portion of the Talisay River has low dissolved oxygen (DO) and failed to comply with the minimum Class C Standard of 5 mg/L for the month of July. For the Orani River's downstream, it has failed to comply for two (2) out of five (5) recorded months. As the temperature is associated with DO, the possible cause of monitored low DO is the high temperature recorded during those quarters. Another could be the excessive algae growth in the water.

Despite having favorable result, it is still recommended that the concerned LGUs continue the monitoring of all activities occurring in the river network as well as establishing regulations on the wastewater/septage management systems of household and commercial establishments near or along the riverbanks, particularly the downstream portion of the river.











Ambient Air Quality Monitoring System was not able to retrieve reliable data for this year and is under repair and maintenance. PG-ENRO is looking into new technology such as subscription-based air quality sensing which can provide continuous and reliable data for a much lower cost.







The PG-ENRO also issues Certificate of Environmental Compliance (CEC) to poultry farms and piggeries, as part of their compliance with Provincial Ordinance No. 3, Series of 2019 or the Bataan Environment Code; and Provincial Ordinance No. 8, series of 2019 or the Revised Ordinance Regulating the Operation of Piggeries, Poultry Farms and Other Livestock Raising Entities in the Province of Bataan. For CY 2022, this office was able to evaluate, process, and issue CECs to 53 compliant poultry and livestock farms in the province.



Carbon Neutral Bunker

In line with the long-term goal of making Bataan the first carbon neutral province in the Philippines, one of the initial objectives targeted by the Provincial Government includes transitioning the Bunker into an entity with low carbon operations.

In conducting an Entity-Level Greenhouse Gas (GHG) Emissions Inventory for C.Y. 2021, activity data including electricity consumption and fuel consumption were obtained from the Bunker Property Management Office and the Provincial Engineer's Office respectively. However, data on fuel consumption was not disaggregated and only reflected diesel consumption for mobile combustion. Using the basic formula of activity data multiplied by the emission factor and global warming potential, the total GHG emissions were calculated.



Based on the results of the said emissions inventory, a GHG Management Plan was formulated in September. The said Plan contained strategies that would help manage and significantly reduce GHG emissions at the Bunker focusing on energy efficiency and conservation, trip optimization, waste minimization, proper waste handling, and awareness raising. Following a series of dialogues with the Provincial Administrator and Bunker Property Management Office, the Bataan Provincial Compound Energy Conservation Policy was issued and posted online in November, serving as guide for offices and departments at the Bunker to observe energy conservation measures.
