COMMITTEE REPORT

COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on August 31, 2022 and discussed the referred agendas assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

1. Agenda No. 322 – Ordinance No. 18, series of 2022, passed by the Sangguniang Bayan of Hermosa, Bataan, entitled, "AN ORDINANCE SPECIFYING THE RATES OF SEPTAGE FEES IN THE MUNICIPALITY OF HERMOSA."

Section 2 (c) of Republic Act No. 9275 or the "Philippine Clean Water Act of 2004", recognizes that water quality management issues cannot be separated from concerns about water sources and ecological protection, water supply, public health and quality of life.

2. Agenda No. 329 – Municipal Ordinance No. 09, series of 2022, passed by the Sangguniang Bayan of Bagac, Bataan, entitled, "AN ORDINANCE FIXING THE ANCHORAGE FEES FOR MOTORBOATS, SHIPS AND OTHER SEA VESSELS WITHIN THE MUNICIPAL WATERS OF BAGAC, BATAAN."

The LGU of Bagac prioritize the protection of the environment as its moral task. Henceforth, the said ordinance was passed to regulate the offshore mooring or anchorage by fixing the anchorage fees of the owners or operators of motorboats, ships and other sea vessels that anchor within the municipal waters of Bagac.

3. Agenda No. 330 - Supplemental Budget No. 01 series of 2022 of the Municipality of Mariveles, Bataan, involving a total appropriation of ₱34,000,000.00 under Appropriation Ordinance No. 02, series of 2022.

Under Section 327 of the Local Government Code of 1991, the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within the same period prescribed for the review of other ordinances. The aforementioned appropriation ordinances complied with the requirements set forth by the Local Government Code and the Provincial Budget Officer did not interpose any objection to the same.

In addition, compliance with existing accounting and auditing rules and regulations shall be the sole responsibility of the Municipality of Mariveles, Bataan.

Capitol Compound, Balanga City, Bataan, Philippines Finding the above mentioned Ordinances within the scope of the prescribed powers of the Sangguniang Bayan, we therefore request for the approval of resolutions declaring the validity of **Agenda Nos. 322, 329 and 330** respectively before this Body upon proper suspension of the rules.
