COMMITTEE REPORT

COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on July 6, 2022 and discussed the referral letter assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

- 1. Agenda No. 189 – Letter from Hon. Albert S. Garcia, Provincial Governor of Bataan, RE: Request for a Resolution Authorizing and Approving the Monthly Allowance of PAFC Chairperson, C/MAFC Chairperson and C/MFARMC Chairperson.**

In cognizance of the efforts and initiatives of the respective chairpersons in leading their respective councils as well as their contributions in the agriculture and fisheries sector that helps boost our economic development, granting them monthly allowance is believed to be in order and well-deserved. This will help them cover transportation and other expenses in the performance of their duties and to encourage them to strive further for the benefit of the province.

Additional budget amounting to ₱25,000/month was incorporated in the Annual Budget for FY 2022 of the Office of the Provincial Agriculture.

We therefore move for the approval of **Agenda No. 189** before this Body upon proper suspension of the rules.

- 2. Agenda No. 234 – Supplemental Budget No. 02 of the Municipality of Morong, Bataan, involving an appropriation of ₱10,792,841.90 under Appropriation Ordinance No. 02 series of 2022.**
- 3. Agenda No 238 – Supplemental Budget No. 04 of the Municipality of Limay, Bataan, involving an appropriation of ₱143,009,666.18 under Appropriation Ordinance No. 2022-005.**
- 4. Agenda No. 245 – Supplemental Budget No. 01 of the Municipality of Samal, Bataan, involving an appropriation of ₱2,433,583.00 under Appropriation Ordinance No. 22-001.**

Under Section 327 of the Local Government Code of 1991, the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within the same period prescribed for the review of other ordinances. The aforementioned appropriation ordinance complied with the requirements set forth by the Local Government Code and the Provincial Budget Officer did not interpose any objection to the same.

In addition, compliance with existing accounting and auditing rules and regulations shall be the sole responsibility of the Municipalities of Morong, Limay and Samal, Bataan.
