## **COMMITTEE REPORT**

## COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on July 20, 2022 and discussed the referred Agenda assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

- 1. Agenda No. 252 Supplemental Budget No. 03 of the Municipality of Orion, Bataan, involving a total appropriation of \$\P38,190,927.94\$ under Appropriation Ordinance No. 2022-03.
- 2. Agenda No. 256 Supplemental Budget No. 02 series of 2022 of the Municipality of Hermosa, Bataan, involving a total appropriation of ₱30,011,242.88 under Appropriation Ordinance No. 2, series of 2022.
- 3. Agenda No. 273 Supplemental Budget No. 04 of the General Fund FY 2022 of the Municipality of Orion, Bataan, involving a total appropriation of ₱1,320,000.00 under Appropriation Ordinance No. 2022-04.
- 4. Agenda No. 276 Supplemental Budget No. 04 for CY 2022 of the Municipality of Pilar, Bataan, involving a total appropriation of \$\mathbb{P}^2,700,000.00\$ under Appropriation Ordinance No. 04, S. 2022.

Under Section 327 of the Local Government Code of 1991, the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within the same period prescribed for the review of other ordinances. The aforementioned appropriation ordinances complied with the requirements set forth by the Local Government Code and the Provincial Budget Officer did not interpose any objection to the same.

In addition, compliance with existing accounting and auditing rules and regulations shall be the sole responsibility of the Municipalities of Orion, Hermosa, and Pilar, Bataan, respectively.

We therefore request for the approval of resolutions declaring the validity of **Agenda Nos. 252, 256, 273 and 276** respectively before this Body upon proper suspension of the rules.



5. Agenda No. 280 - Municipal Ordinance No. 10, series of 2022 passed by the Sangguniang Bayan of Orani, Bataan, entitled, "AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE APPROVED LOAN OF MUNICIPALITY OF ORANI, BATAAN IN THE AMOUNT NOT TO EXCEED TWENTY-ONE MILLION EIGHT HUNDRED THOUSAND (Php21,800,000.00) TO FINANCE THE EQUITY PORTION OF THE CONSTRUCTION OF MULTI-PURPOSE EVACUATION CENTER AND REHABILITATION OF THE VEGETABLE SECTION AND FAÇADE OR ORANI PUBLIC MARKET AS AGREEMENT, TERM LOAN CONTAINED IN THE ASSIGNMENT AND OTHER DOCUMENTS RELATED THERETO SIGNED AND EXECUTED BETWEEN THE MUNICIPALITY OF ORANI, BATAAN AND THE DEVELOPMENT BANK OF THE PHILIPPINES.

As stated in the Ordinance, the said loan would be used for equity portion of the construction of Multi-Purpose Evacuation Center and Rehabilitation of the Vegetable Section and Façade at Orani Public Market. The obligations of the Municipality, as well as the terms and conditions for the said borrowing, shall be valid and binding on the LGU and shall not be subject to recall, revocation or rescission by the Sangguniang Bayan until the loan is fully paid, regardless of any change in the composition of the Sangguniang Bayan.

The above mentioned ordinance is found to be passed within the bounds of the prescribed powers of the Sangguniang Bayan of Orani, Bataan. We therefore move to declare the validity of Agenda No. 280 upon suspension of the rules.
