



COMMITTEE REPORT

COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on July 13, 2022 and discussed the referral letter assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

- 1. Agenda No. 258 – Municipal Ordinance No. 09 series of 2022** passed by the Sangguniang Bayan of Orani, Bataan, entitled, "AN ORDINANCE AUTHORIZING THE MUNICIPAL VICE-MAYOR TO MAKE AN AUGMENTATION OF APPROPRIATION FROM TELEPHONE EXPENSES (100,000.00) INTERNET SUBSCRIPTION EXPENSES (P80,000.00) MEMBERSHIP DUES & CONTRIBUTION TO ORGANIZATION (P50,000.00) LEGAL SERVICES (P50,000.00) REPAIR & MAINTENANCE-BLDGS & OTHER STRUCTURES (P15,000.00) REPAIR/MAINTENANCE-MACHINERY & EQUIPMENT (P15,000.00) REPAIR & MAINTENANCE-TRANSPORTATION EQUIPMENT (P15,000.00) OTHER MAINTENANCE & OPERATING EXPENSES (P20,000.00) TO TRAVELLING EXPENSES (P50,000.00) TRAINING EXPENSES (P295,000.00) OFFICE OF THE MUNICIPAL VICE-MAYOR."

Under Section 336 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, the local chief executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved annual budget for their respective offices from savings in other items within the same expense class of their respective appropriations.

The disbursement of the funds under this Ordinance shall be in accordance with the accounting and auditing rules and procedures.

- 2. Agenda No. 260 – Ordinance No. 19, S. 2022** passed by the Sangguniang Bayan of Pilar, Bataan, entitled, "ADDENDUM TO CHAPTER V, ARTICLE D OF ORDINANCE NO. 9, S. 2012, ENTITLED, "THE REVISED REVENUE CODE OF THE MUNICIPALITY OF PILAR, BATAAN", IMPOSING MONTHLY RENTAL FEE FOR THE LEASE OF ANY PORTION OF PARK AND OTHER LOTS OWNED BY THE MUNICIPALITY OF PILAR, BATAAN."

This Ordinance shall cover the collection of monthly rental fee for any portion of Park and other Lots owned by this Municipality use as location for the operation of privately-owned business establishment.

Imposition of Monthly Rental Fee will be collected from the Lessee the amount of **TWO HUNDRED PESOS (P200.00)** per square meter of any portion of Park and other Lot owned by the Municipality.

3. Agenda No. 263 – City Ordinance No. 34, S. 2022 passed by the **Sangguniang Panlungsod of Balanga, Bataan**, entitled, "AN ORDINANCE GRANTING RELIEF ON SURCHARGES AND INTERESTS ON LOCAL TAX ON TRANSFER OF REAL PROPERTY OWNERSHIP IN SUPPORT OF THE ESTATE TAX AMNESTY PROGRAM OF THE NATIONAL GOVERNMENT."

Under Section 4 of Republic Act (RA) No. 11213, otherwise known as the Tax Amnesty Act, mandates the grant of a one-time opportunity for taxpayers to settle their estate tax obligations, through an estate tax amnesty program, for taxable years 2017 and prior (RA No. 11213 was further amended by RA 11569 extending the Estate Tax Amnesty)

The above mentioned ordinances found to be within the bounds of the prescribed powers of the local government units. We therefore move to declare the validity of Agenda Nos. 258, 260 and 263 upon suspension of the rules.
