COMMITTEE REPORT

COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on July 27, 2022 and discussed the referred agendas assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

1. Agenda No. 283 - Municipal Ordinance No. 2022-362, passed by the Sangguniang Bayan of Limay, Bataan, entitled "AN ORDINANCE SECTION 29 (29.2)-PERTINENT PROVISIONS ON STALL'S OCCUPANCY, SECTION 30 - LEASE PERIOD AND SECTION 38 - RENTAL FEE OF STALL/SPACE AT THE PERMANENT MARKET BUILDING OF THE MUNICIPAL ORDINANCE NO. 11-234 ALSO KNOWN AS "AN ORDINANCE ESTABLISHING THE "2011 MARKET CODE OF THE MUNICIPALITY OF LIMAY, BATAAN."

The renovation of the New Limay Public Market is expected to be completed on July 2022, hence, it is necessary to amend certain provisions of the Market Code to provide for a better public market management, maintenance and operations in order to enhance competitiveness, business and livelihood opportunities and to ensure delivery of basic services to the community.

2. Agenda No. 285 - Municipal Ordinance No. 06, series of 2022, passed by the Sangguniang Bayan of Bagac, Bataan, entitled, "AN ORDINANCE ENACTING THE HIMLAYANG BAGAKENO CODE."

The Municipality of Bagac shall promote social justice in all phases of development, protect and promote the right to health of its people and values the dignity of every human individual and guarantees respect for their human rights. As such the said Municipality shall endeavor to provide a dignified resting place for its citizens.

This code will govern the operation, management and improvement of the HIMLAYANG BAGAKENO and shall be effective immediately upon compliance with the posting and publication requirements as mandated by the existing laws and legal statutes.

Our Committee finds the above mentioned ordinances found to be passed within the bounds of the prescribed powers of the Sangguniang Bayan of Limay and Bagac. We therefore move to declare the validity of Agenda Nos. 283 and 285 upon suspension of the rules.
