## COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS


Our committee conducted a committee meeting on September 28, 2022 and discussed the referred agendas assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

- 1. Agenda No. 357 Supplemental Budget No. 02, series 2022 of the Municipality of Mariveles, Bataan, involving a total appropriation of ₱49,203,910.68 under Appropriation Ordinance No. 03 Series of 2022.
- 2. Agenda No. 369 Supplemental Budget No. 05 series of 2022 of the Municipality of Bagac, Bataan, involving a total appropriation of ₱3,197,030.78 under Appropriation Ordinance No. 07 Series of 2022.
- 3. Agenda No. 370 Supplemental Budget No. 06 series of 2022 of the City of Balanga, Bataan, involving a total appropriation of ₱19,199,810.00 under Appropriation Ordinance No. 06, series of 2022.
- 4. Agenda No. 376 Supplemental Budget No. 02 series of 2022 of the Municipality of Dinalupihan, Bataan, involving a total appropriation of ₱8,751,475.42 under Appropriation Ordinance No. 06-2022.
- 5. Agenda No. 377 Supplemental Budget No. 07, series of 2022 of the City of Balanga, Bataan, involving a total appropriation of \$\mathbb{P}27,903,709.23\$ under Appropriation Ordinance No. 07, series of 2022.
- 6. Agenda No. 379 Supplemental Budget No. 05, of the General Fund FY 2022 of the Municipality of Orion, Bataan, involving a total appropriation of ₱1,573,796.60 under Appropriation Ordinance No. 2022-05.

Under Section 327 of the Local Government Code of 1991, the Sangguniang Panlalawigan shall review the ordinance authorizing annual or supplemental appropriations of component cities and municipalities in the same manner and within the same period prescribed for the review of other ordinances. The aforementioned appropriation ordinances complied with the requirements set forth by the Local Government Code and the Provincial Budget Officer did not interpose any objection to the same.

In addition, compliance with existing accounting and auditing rules and regulations shall be the sole responsibility of the Municipalities of Mariveles, Bagac, Dinalupihan, Orion and City of Balanga, Bataan, respectively.

We therefore request for the approval of resolutions declaring the validity of **Agenda Nos. 357, 369, 370, 376, 377 and 379** respectively before this Body upon proper suspension of the rules.
