



COMMITTEE REPORT

COMMITTEE ON FINANCE, BUDGET, APPROPRIATIONS, AND WAYS AND MEANS

Our committee conducted a committee meeting on September 21, 2022 and discussed the referred agendas assigned to the committee of the undersigned, the following items in the Order of Business, to wit:

- 1. Agenda No. 365 – City Ordinance No. 45, S.,** passed by the **Sangguniang Panlungsod of Balanga, Bataan**, entitled, "AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY OF BALANGA, IN THE AMOUNT OF ONE HUNDRED FORTY-THREE MILLION PESOS (PHP 143,000,000.00) TO FUND THE CONSTRUCTION OF FOUR-STOREY, 24-CLASSROOM SCHOOL BUILDING LOCATED AT BATAAN NATIONAL HIGH SCHOOL BARANGAY TENEJERO, BALANGA CITY, BATAAN AND THE CONTRUCTION OF FOUR-STOREY, 20-CLASSROOM SCHOOL BUILDING LOCATED AT BARANGAY DANGCOL, BALANGA CITY, BATAAN."

Under Section 2 of the ordinance, the aforementioned priority projects to be funded by the proceeds of the loan are certified to be a local infrastructure and/or other socio-economic development projects in accordance with the approved Local Development Plan and Public Investment Program of the City.

Upon reviewing the same, we determined that the ordinance was passed within the scope the prescribed powers of the Sangguniang Panlungsod of Balanga. We therefore request for the approval of a resolution declaring the validity of **Agenda No. 365** before this Body upon proper suspension of the rules.

- 3. Agenda No. 370 - Supplemental Budget No. 06 series of 2022 of the City of Balanga, Bataan**, involving a total appropriation of **₱19,199,810.00** under **Appropriation Ordinance No. 06, series of 2022.**
