COMMITTEE REPORT

COMMITTEE ON HEALTH

Formally referred to the SP Committee on Health was **Agenda No. 288 – Ordinance No. 15**, **series of 2022**, passed by the Sangguniang Bayan of Hermosa, Bataan, entitled "AN ORDINANCE INSTITUTING A FUNCTIONAL DISASTER RISK REDUCTION AND MANAGEMENT HEALTH SYSTEM (DRRM-H) IN THE MUNICIPAL-WIDE HEALTH SYSTEMS OF THE MUNICIPALITY."

Section 2 (a) of Republic Act No. 11223 or "Universal Health Care (UHC) Act" provides that the state shall adopt an integrated and comprehensive approach to ensure that all Filipinos are health-literate, provided with healthy living conditions and protected from hazards and risks that could affect their health.

The subject ordinance seeks to; (1) institutionalize a functional DRRM-H System within the Municipal-Wide Health System (MWHS) of Hermosa to manage and mitigate the adverse effects/impacts and health consequences of emergencies/disasters including climate change (2) organize and implement a functional DRRM-H System through procedures and technical specifications necessary for the operationalization and transition (3) promote the involvement and participation of all sectors and all stakeholders concerned, at all levels, especially the local community and (4) allocate resources for the operationalization of a functional DRRM-H System at the MWHS.

After deliberation by this committee, as concluded in our committee meeting dated **August 3, 2022**, we find that the said ordinance was enacted by the **Sangguniang Bayan of Hermosa, Bataan** within the scope of its prescribed powers, in consonance with Section 447 of the Local Government Code of 1991. Hence, we would like to recommend to declare the validity of **Agenda No. 288** subject to and without prejudice to the applicable laws, rules, regulations and policies after the suspension of the rules.
