COMMITTEE REPORT COMMITTEE ON LABOR, MANPOWER, EMPLOYMENT AND GOVERNMENT SERVICES

Our committee received a referral concerning the following matters:

Agenda No. 428 - Letter from Hon. Jose Enrique S. Garcia III, Provincial Governor of Bataan, RE: REQUEST FOR A RESOLUTION AUTHORIZING THE PROVINCIAL GOVERNOR, HON. JOSE ENRIQUE S. GARCIA III TO ENTER INTO AND SIGN A COLLECTIVE NEGOTIATION AGREEMENT WITH THE PROVINCIAL ASSOCIATION OF GOVERNMENT EMPLOYEES (PAGE-BATAAN).

The **PAGE-BATAAN** is the only existing legitimate employee association of the Provincial Government of Bataan and is the sole and exclusive representative of the rank-and-file employees.

It is the desire of the parties to enter into an agreement to foster and promote noble and enduring relationships between the members of PAGE-BATAAN and management through development of harmonious and sound labor management practices for the purpose of attaining maximum efficiency in improving the welfare and well-being of the workers through better terms and working conditions of employment, including settlement of all grievances and disputes that may arise between parties.

Agenda No. 433 - Letter from Hon. Jose Enrique S. Garcia III, Provincial Governor of Bataan, RE: REQUEST FOR SP RESOLUTION FOR THE USE OF THE POSITION TITLE, PROVINCIAL GOVERNMENT ASSISTANT DEPARTMENT HEAD WITH NO PARENTHETICAL TITLE, ASSISTANT SECRETARY TO THE SANGGUNIANG PANLALAWIGAN.

This pertains to the position title as indicated on the Annual Budget 2022 of the Provincial Government Assistant Department Head with parenthetical title, Assistant Secretary to the Sangguniang Panlalawigan. This parenthetical title does not exist in the list of positions in Local Budget Circular #137, in Local Government Code of 1991 (RA 7160) and to the Qualification Standard (QS) Manual Revised 1997, and can never be used as parenthetical title attached to Provincial Government Assistant Department Head position, hence the said request.

The committee after its deliberation held last October 19, 2022 finds the requests proper. We hereby recommend for the approval of Agenda Nos. 428 and 433 after rules are suspended.


