COMMITTEE REPORT COMMITTEE ON PEACE AND ORDER & PUBLIC SAFETY

The following agenda were referred for review and evaluation of the herein committee, in accordance with the Order of Business, to wit:

Agenda 461 - Municipal Ordinance No. 12, series of 2022, passed by the Sangguniang Bayan of Bagac, Bataan, entitled, "AN ORDINANCE REQUIRING ALL COMMERCIAL ESTABLISHMENTS WITHIN THE MUNICIPALITY OF BAGAC TO INSTALL CLOSED CIRCUIT TELEVISION (CCTV) SECURITY SYSTEM WITHIN THEIR RESPECTIVE FACILITIES AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Agenda 463 - Municipal Ordinance No. 14, series of 2022, passed by the Sangguniang Bayan of Orani, Bataan, entitled, "AN ORDINANCE MANDATING ALL COMMERCIAL ESTABLISHMENTS TO INSTALL CLOSE CIRCUIT TELEVISION (CCTV) SECURITY SYSTEM WITHIN THEIR RESPECTIVE FACILITIES AND PROVIDING PENALTIES FOR VIOLATION THEREOF."

Section 16 of Republic Act 7160, otherwise known as the Local Government Code of 1991, provides that "every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare."

Commercial establishments are mostly at risk to criminal activities, not just robberies, thus the need for the right security system to monitor nearby activities and inside the business area is very important to prevent or deter criminals from even thinking of assaulting the place. With this, it is imperative to require all commercial establishments within the Municipalities of Bagac and Orani to have a basic functioning or working CCTV system to help prevent and resolve crime in the fastest way possible.

After deliberation during our committee meeting on November 9, 2022, we find that the said ordinances were passed within the scope of prescribed powers of the Sanggunian. The committee therefore recommends to declare the validity of Agenda Nos. 461 and 463 upon suspension of the rules.
