



**COMMITTEE REPORT**  
**COMMITTEE ON TRANSPORTATION AND COMMUNICATION**

This has reference to the referral to the Committee on Transportation and Communication, to wit:

**1. Agenda No. 364 - City Ordinance No. 44, series of 2022, passed by the Sangguniang Panlungsod of Balanga, Bataan, entitled "AN ORDINANCE AMENDING ORDINANCE NO. 20, S. 2011 BY INCREASING THE TRICYCLE FARE BY TWO PESOS (PHP2.00) IN THE CITY OF BALANGA, BATAAN."**

The City of Balanga passed an Ordinance for the increase of the tricycle fare by two pesos (Php 2.00) to lessen the economic burden of the tricycle drivers in the locality. The existing tricycle fare in the City of Balanga is not anymore commensurate to the current living situation, especially for the tricycle operators and drivers. The pandemic, the unstable oil price, cost of everyday living makes the tricycle fare insignificant to satisfy all their needs so it is deemed fair and justifiable to have two pesos (Php 2.00) increase in the Public Utility Tricycle.

**2. Agenda No. 366 - Ordinance No. 21, series of 2022, passed by the Sangguniang Bayan of Hermosa, Bataan, entitled "AN ORDINANCE ENACTING THE TRAFFIC MANAGEMENT CODE OF THE MUNICIPALITY OF HERMOSA."**

The Municipality of Hermosa passed an Ordinance that enacts the Traffic Management Code in the Municipality. The purpose is to provide efficient and effective traffic rules and regulations on all kinds of road in the municipality whether national or local in classification, for the management of traffic and safer use of roads, streets, avenues, highways and alleys by all types of motor vehicle. Also, the flow of people and goods through its road network shall be as efficient, safe, unhampered and orderly as possible. This Ordinance will improve economic and social vitality of the constituents of Hermosa.

**3. Agenda No. 368 - Municipal Ordinance No. 10, series of 2022, passed by the Sangguniang Bayan of Bagac, Bataan, entitled "FIXING THE RATES OF TRICYCLE FARE WITHIN THE MUNICIPALITY OF BAGAC, BATAAN."**

Tricycle is the primary means of transportation in the Municipality of Bagac, so they passed an Ordinance that fixed the rate of tricycle fare within their constituents.

The committee after our deliberation held last September 21, 2022, finds the said Ordinances passed within the scope of the prescribed powers conferred to Sangguniang Bayan under Section 447 (a) of the Local Government Code of 1991. We hereby recommend the declaration of validity of Agenda Nos. 364, 366 and 368 under the suspension of the rules.
