COMMITTEE REPORT

Committee on Youth and Sports Development

This pertains to Agenda No. 321- Municipal Ordinance No. 001 Series of 2022 passed by the Sangguniang Bayan of Dinalupihan, Bataan, entitled, "AN ORDINANCE DECLARING THE MONTH OF AUGUST AS THE MUNICIPAL YOUTH MONTH AND AUGUST 12 AS THE MUNICIPAL YOUTH DAY IN THE MUNICIPALITY OF DINALUPIHAN, BATAAN, AND ENJOINING ALL FORTY-SIX (46) BARANGAYS TO ACTIVELY PARTICIPATE IN ITS CELEBRATION."

Article II, Section 13 of the 1987 Phillippine Constitution provides that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual, and social well-being.

In addition, the SK Reform Act 2015 mandates that every barangay, municipality, city and province shall conduct an annual activity to be known as the **Linggo ng Kabataan** on the week where the 12th of August falls to coincide with the International Youth Day. The Sangguniang Kabataan, in the case of barangay, and the respective LYDC in cooperation with the Pederasyon ng mga Sangguniang Kabataan, in the case of municipality, city and province, shall take the lead in this observance.

Towards this end, the Municipality of Dinalupihan calls for all the local elective and appointive officials, national agencies and barangay officials to take responsibility for coordinating and addressing the needs and concerns of the youth which may be addressed by engaging them to governance and bureaucracy, as one of the effective ways to develop a compassionate and good leaders in the future.

Section 10 of the said Ordinance provides that FAILURE TO OBSERVE THE PROVISIONS OF THIS ORDINANCE SHALL BE DEALT THE PENALTIES IMPOSED UNDER R.A 10742. After conducting a review during our committee meeting held on August 31, 2022, our committee finds the said provision to be invalid as it is beyond the power conferred to the LGU to impose the said penalty especially to national agencies as mentioned. We hereby request to declare the said Ordinance **INVALID** in part as Sec. 10 thereof was beyond the power conferred to the Sangguniang Bayan.
