In response to the first advertisement for *Supply, Fabrication and Delivery of Bunkbeds for BJMP - Barangay Dana, Orani, Bataan*, nobody purchased and submitted bidding documents which is scheduled to be opened last March 29, 2022 at 1:30 p.m.;

Bids received in excess of the ABC shall be automatically rejected a bid opening..
