### INVITATION TO BID

In response to the first advertisement for Rehabilitation and Improvement of Multi-Purpose Building Barangay Binuangan, Bagac, Batangas, nobody purchased and submitted bidding documents which is scheduled to be opened last April 4, 2022 at 1:30 p.m.

Under Section 33, of RA 9184, the BAC shall declare failure of bidding when no bids are received. The BAC members resolved to declare Failure of Bidding and recommended to Re-bid the above-mentioned project subject to the approval of the Provincial Governor.

In view of the failure of the first bidding, the Provincial Government of Batangas, through the 20% Development Fund (20%) advertised again the Invitation to Bid for the said projects in the Provincial Government of Batangas Website, in the PhilGEPS and in a conspicuous place at the premises within the Provincial Government of Batangas continuously for seven (7) days; w/ corresponding Approved Budget of the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected a bid opening.

The Provincial Government of Batangas, through the 20% Development Fund (20%) intends to apply the below listed project w/ corresponding Approved Budget of the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected a bid opening.
