In response to the first advertisement for *Improvement of Slage Nagwaling Elementary School Barangay Nagwaling, Pilar, Batangas*, three (3) eligible bidders purchased bidding documents but failed to submit bidding requirements which was opened last March 28, 2022 at 1:30 p.m.

Under Section 25, of RA 9184, the BAC shall declare failure of bidding when no bids are received. The BAC members resolved to declare Failure of Bidding and recommended to Re-bid the above-mentioned project subject to the approval of the Provincial Governor.

In view of the failure of the first bidding, the Provincial Government of Batangas, through the Special Education Fund (SEF) advertised again the Invitation to Bid for the said projects in the Provincial Government of Batangas Website, in the Philippines and in a conspicuous place at the premises within the Provincial Government of Batangas continuously for seven (7) days; w/ corresponding Approved Budget of the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected in bid opening.

The Provincial Government of Batangas, through the Special Education Fund (SEF) intends to apply the below listed project w/ corresponding Approved Budget of the Contract (ABC). Bids received in excess of the ABC shall be automatically rejected a bid opening.
